PROCEDURE FOR PRELIMINARY SUBDIVISION

THE PROCESS:

1. Application and all required information (see checklist) must be submitted.
2. Review comments to the Applicant within 21 days of receipt unless otherwise notified.
4. Revised plans submitted.
5. Planning Board Meeting (usually 3rd Monday ea. month)
6. Actions and Recommendations, Water and Sewer Allocation to the Town Board.
7. Town Board Meeting (usually 1st Monday of each month)
8. Town Board Action Letter to applicant.

Move to Construction Plan Submittal stage.

SUBMITTAL CHECKLIST:

- One (1) completed Application for Major Subdivision Preliminary Plat (original copy, no faxes)
- Preliminary Plat Review Fee: \$600 + \$5.00 per lot OR Amendment to approved preliminary: \$100.00
- 4 (four) maps (no larger than 24" x 36" standard engineer copies) FOLDED to an approximate 8.5"x11" size
- 1 (one) map 11 x 17"
- Recreation Land Dedication Or Fee-In-Lieu Payment Request
- Wake County Public School System (WCPSS Form) Included
- Utility Allocation Request (If requesting Town Utilities) Included
- Original signatures by stated party on all forms.
